Clerk Havens read the minutes of the regular meeting of August 2, 2022.

Moved by Treasurer Potter, supported by Trustee Matkovich that the minutes of the August 2, 2022 meeting be approved as read. Motion carried 5-0

Moved by Treasurer Potter, supported by Trustee Cameron that the accounts payable in the amount of \$33,230.26 be approved. Motion carried 5-0

Moved by Clerk Havens, supported by Treasurer Potter that the amendment to the current Land Division Policy be approved as requested. Motion carried 5-0

Moved by Trustee Cameron approved by Trustee Matkovich that the retirement of Georginna Potter as of September 30, 2022 be approved. Motion carried 5-0

Moved by Clerk Havens, supported by Trustee Matkovich that Julie Stephenson be appointed interim Treasurer until the November 2024 election. Motion carried 5-0

The Township received bids from Autore Oil and Propane and Webster & Garner Inc. for 2022/2023. Moved by Treasurer Potter, supported by Clerk Havens to accept Webster Garner bid of \$1.549 per gallon. Motion carried 5-0

Moved by Treasurer Potter, supported by Trustee Cameron that the Land Division expense budget be increased to \$1,000. Motion carried 5-0

Moved by Treasurer Potter, supported by Trustee Matkovich that the Veterans Fund miscellaneous budget be increased to \$7,500. Motion carried 5-0

Moved by Clerk Havens, supported by Treasurer Potter that the Fire Fund miscellaneous expense budget be increased to \$15,000. Motion carried 5-0

Moved by Treasurer Potter, supported by Trustee Matkovich that the Ambulance Fund miscellaneous expense budget be increased to \$5,000. Motion carried 5-0

Moved by Treasurer Potter, supported by Clerk Havens that the Golf Course Improvement Fund expense budget be increased to \$500. Motion carried 5-0

Moved by Treasurer Potter, supported by Trustee Matkovich that the Road Fund Repair and Maintenance budget be increased to \$4,000. Motion carried 5-0

Moved by Treasurer Potter, supported by Trustee Matkovich that the Golf Course Melissa expense fund budget be increased to \$1,500. Motion carried 5-0

Moved by Treasurer Potter, supported by Trustee Cameron that the Sheriff Salaries expense budget be increased by \$25,000. Motion carried 5-0

Moved by Treasurer Potter, supported by Trustee Matkovich that the Winter Tax miscellaneous expense budget be increased to \$500. Motion carried 5-0

Moved by Treasurer Potter, supported by Trustee Cameron that the Summer Tax miscellaneous expense budget be increased to \$500. Motion carried 5-0

Moved by Treasurer Potter, supported by Trustee Matkovich that the Winter Tax miscellaneous expense budget be increased to \$500. Motion carried 5-0

Moved by Trustee Cameron, supported by Trustee Matkovich that the Town hall be named the "Frank J. Sasso Jr. Township Hall" Motion carried 5-0

There was much discussion about the DNR Spark Grant, ferry concerns, and the bathrooms at the ferry dock.
